**PUBLIC NOTIFICATION**

**Sub:-NEW PHASE OF COVID-19 MANAGEMENT ZHEMGANG**

With the increasing number of positive cases in Buli Chiwog and Tingtibi Zone and in reference to the Press Release issued from the Prime Minister's Office on March 12, 2022 with regard to **New Phase of COVID-19 Management**, the Zhemgang Dzongkhag COVID-19 Task Force hereby announces the following timeline for managing the COVID -19 situation.

Dates	Details of DOs and DON'Ts
March 13-20	Movement of people in Buli Chiwog, Trong Gewog, Tingtibi and Zhemgang zones shall be restricted within the <b>Red Areas</b> only.
	Outbound movement of people from Buli Chiwog, Tingtibi and Zhemgang zones shall not be allowed.
	Positive cases Buli Chiwog and Tingtibi zone shall be evacuated to Tama School and newly constructed Buli hospital staff quarters respectively as non-hospital isolation. However, Primary Contacts (PCs) and members of the household shall remain under strict home quarantine for a duration of 10 days.
	For identified Red Areas, one member from each household shall be allowed to come out for essential shopping with movement cards.
	Identified essential shops within the Buli Chiwog, Tingtibi and Zhemgang zones shall remain open <b>as per the timing of the movement cards</b> . In other areas of Nangkor and Trong Gewogs, business can open till 7 PM.
	For PCs and families in home quarantine, the essentials will be delivered at doorstep based on the order.
	Construction can take place if it is within the same location of Buli Chiwog, Tingtibi and Zhemgang zones in containment mode.
	Medical services shall continue to remain open.
	No mass gathering of any kind.
	Public servants and corporate employees shall <b>work from home</b> if the office is located within Trong Gewog, Buli, Tingtibi and Zhemgang zones. However, financial institutions and fuel depots are allowed to operate with 50% of staff.
	No outdoor and indoor sporting activity is allowed in Buli Chiwog, Tingtibi and Zhemgang zones.

March 21-27	Restaurants/ Bars/ Hotels shall remain closed in Buli, all Chiwogs of Trong Gewog, Tingtibi and Zhemgang zones.
	Feed agents shall be allowed to open based on demand.
	No movement of vehicles shall be allowed in all Chiwogs of Trong Gewog, Buli, Tingtibi and Zhemgang zones.
	People of Buli Chiwog and Trong Gewog shall be allowed for movement within the Chiwogs only.
	Identified Primary Contacts and members of the household shall remain under strict home quarantine for a duration of 10 days.
	For identified Red Areas, one member from each household shall be allowed to come out for essential shopping with movement cards.
	Identified essential shops within the Red Area shall remain open as per the <b>timing of the movement cards</b> . In other areas of Nangkor and Trong Gewogs, Tingtibi and Zhemgang zones the business can open till 7 PM.
	For PCs and families in home quarantine, the essentials will be delivered at doorstep based on the order.
	No out-bound movement shall be allowed from communities identified as Red Areas.
	Construction can take place if it is within the same location of Buli Chiwog, Tingtibi and Zhemgang Throm in containment mode.
	Medical services shall continue to remain open.
	No mass gathering of any kind.
	Public servants and corporate employees shall be <b>encouraged to work from home</b> if the office is located within Red areas/zones. However, financial institutions and fuel depots are allowed to operate with 50% of staff
	Outdoor sporting activities involving less than 10 people including spectators shall be allowed.
	Indoor sporting activities such as Snooker/ Carom/ Video gaming in public places shall not be allowed.
	Restaurants/ Bars/ Hotels within Trong Gewog, Buli, Zhemgang and Tingtibi shall open only for takeaway.
	Feed agents shall be allowed to open based on demand.
	No movement of vehicles shall be allowed in <b>Red areas</b> only.



<b>March 28-April 03</b>	People of Nangkor and Trong Gewogs shall be allowed for movement within respective Gewog only.
	Identified Primary Contacts and members of the household shall remain under strict home quarantine for a duration of 10 days.
	For identified Red Areas one member from each household shall be allowed to come out for essential shopping with movement cards.
	Identified essential shops within the Red Area shall remain open as per the timing of the movement cards. In other areas of Trong Gewog, Buli chiwog, Zhemgang and Tingtibi Throm the business can open till 7 PM.
	For PCs and families in home quarantine, the essentials will be delivered at doorstep based on the order.
	No out-bound movement shall be allowed from communities identified as Red Area.
	Except for entertainment centers, all other business entities can open till 7 PM.
	Medical services shall continue to remain open.
	No mass gathering of any kind.
	Public servants and corporate employees shall be <b>encouraged</b> to work from home if the office is within Trong Gewog, Buli, Tingtibi and Zhemgang Throm. However, financial institutions and fuel depots are allowed to operate with 50% of staff.
	Outdoor sporting activities involving less than 10 people including spectators shall be allowed. Indoor sporting activities such as Snooker/ Carom/ Video gaming in public places shall not be allowed.
	Taxis are allowed to ferry people of the same cohort within Trong Gewog, Buli, Tingtibi and Zhemgang Zones but movement of other vehicles are not allowed.
<b>April 04-10</b>	People of Trong Gewog, Buli Chiwog, Tingtibi and Zhemgang Zones shall be allowed for movement within the Dzongkhag.
	Identified Primary Contacts and members of the household shall remain under strict home quarantine for a duration of 10 days.
	For identified Red Areas one member from each household shall be allowed to come out for essential shopping with movement cards.
	Identified essential shops within the Red Area shall remain open as per the timing of the movement cards. In other areas of Trong Gewog, Buli chiwog, Tingtibi and Zhemgang zones, the business can open till 7 PM.
	For Red building and home quarantine, the essentials will be delivered at doorstep based on the order.

	Except for entertainment centers, all other business entities can open till 7 PM within Dzongkhag.
	Medical services shall continue to remain open.
	No mass gathering of any kind.
	Public servants and corporate employees shall be encouraged to work from home if the office is within Trong Gewog, Buli Chiwog, Zhemgang and Tingtibi Throm.
	Outdoor sporting activities involving less than 10 people including spectators shall be allowed. Indoor sporting activities such as Snooker/ Carom/ Video gaming in public places shall not be allowed.
	Movement of all vehicles are allowed.
<b>April 11</b>	All offices to be fully operational
<b>April 25</b>	Schools to be opened in Buli Chiwog, Trong gewog, Tingtibi and Zhemgang zones as per the date announced by the Government.
	All businesses in Buli Chiwog, Trong gewog, Tingtibi and Zhemgang zones can operate until 9 PM.
	All sporting activities will be allowed without spectators across Dzongkhag.

**Note: The above shall be applicable to Buli Chiwog, Trong Gewog, Tingtibi and Zhemgang zones only**

In addition to the COVID-19 health safety protocols, all the people are hereby requested to exercise self-discipline while performing our routine activities and avoid unnecessary travels and gatherings.

**This New Phase of COVID 19 Management shall come into effect from 5am on 14 March 2022.**
