Functioning of the Interim Local Governments (ILG)

1. The ILG shall succeed the elected Local Government and function on the same principles as the Local Government but with limited powers.
2. The ILG shall ensure the continuance of all routine local government functions in a seamless manner till the next elected Local Government assumes office after elections;
3. The ILG shall ensure smooth implementation of the Gewog's planned activities;
4. The ILG shall aid and support the Dzongkhag Election Dispute Settlement Body with regard to election disputes; and
5. The ILG shall assess the affairs arising from developments in the communities under its jurisdiction.

The primary responsibility of the ILG shall be to ensure stability and harmony in the communities and that the elections are held free and fair. It shall ensure that parliamentarians, civil servants and local government officials do not influence the voters.

The Interim Local Government shall assist the Dzongkhag Administration and enable the Election Commission of Bhutan to hold free and fair elections in the Gewog, and enhance harmony, unity, happiness and well-being of the people in the Gewog.

The Gewog Administrative Officer shall function as the interim head of the Gewog and ex-officio chairperson of the ILG.

The ILG shall not:

1. Formulate any plan or new activities;
2. Determine, mobilize and allocate resources;
3. Enter into agreement with external entities.

The ILG shall avoid taking any controversial decisions and committing to any process that is not reversible by the incoming local government.

The ILG shall facilitate broad oversight of the affairs in the communities and efficient interaction/interface between the ILG and its constituents.

This Local Government Order is issued on 25 October 2021 for compliance by all sectors, external agencies and people of the Gewog.
